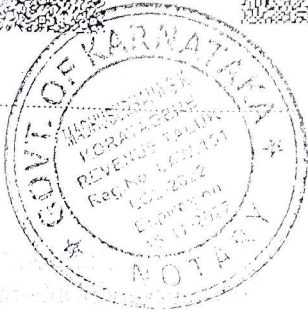
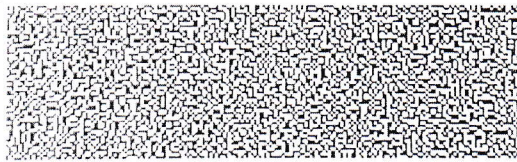
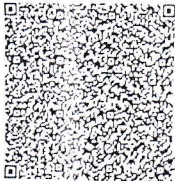

In case any deficiencies are pointed out either by the inspection committee or by CBSE, the same will be rectified and compliance will be submitted within three months to the CBSE.

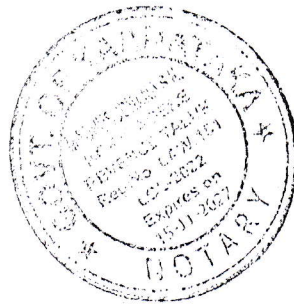


